Town Board Meeting June 17th, 2024, Minutes

Supervisor – Jamie Morin made a Motion to approve the May 20th & 23rd, 2024 minutes as printed, Chairman – David Robers second the Motion. Motion carried unanimously.

<u>Treasurer's Report:</u> \$1,966,866.59 in cash assets as of 06/17/2024 per Treasurer - Sharri Loveless. Chairman – David Robers Motioned to approve, Supervisor – Jamie Morin second the Motion. Motion carried unanimously.

Fire Chief's Report: None.

Road Report: Road Supervisor - Greg Walbrandt advised he fixed the gas line on Foster Road. Put no through truck signs on Stallman Road. Started prep work on Plantation Road. Pressure washed the trucks and undercoated one of them. He installed the pier. Mowed Millard Cemetery a few times and the ditches.

Unsightly Debris on County H: Tabled to July's meeting.

Agreement: Town of La Grange, Lauderdale Lake District and Sugar Creek: The purpose of the agreement is to support the policing provided on the lake. Chairman – David Robers made a Motion to approve. Supervisor – Jamie Morin second the Motion. Motion carried unanimously.

<u>Lake Wandawega: Lake District Formation:</u> John Consolino, and current members, would like to meet with the County to elect five additional permanent members. They would like to host the meeting at Sugar Creek Town Hall on August 10th 2024 at 11:00am. Chairman – David Robers made a Motion to approve. Supervisor – Jamie Morin second the Motion. Motion carried unanimously.

Walworth County Ordinances: Reviewed.

Millard Cemetery: The Township was given the cemetery to maintain. Chairman – David Robers would like to create a new map by plotting out the graves with a company that provides ground penetrating radar. The approximate cost is \$16,000. The current map is a drawing on a piece of cardboard. The costs for a gravesite is \$500.00 and \$150.00 for perpetual care. Eagle Scout, Gus will be cleaning the cemetery on July 13th & 14th from 9:00 – 5:00. Chairman – David Robers would like to provide the volunteers with food and water. Chairman – David Robers would like approval of funds for approximately \$17,500 to complete this project. Chairman – David Robers made a Motion to approve. Supervisor – Jamie Morin second the Motion. Motion carried unanimously.

Permit Fee Increases: Tabled to July's meeting.

Town Hall Floor Buffering Services: Clerk – Sara Morin would like to have the floors professionally buffed. The estimated costs are \$300.00 - \$500.00. Chairman – David Robers made a Motion to approve not to exceed \$500.00. Supervisor – Jamie Morin second the Motion. Motion carried unanimously.

Unmaintained Roads Permit: Tabled to July's meeting.

<u>Maintained Roads Map:</u> Attorney – Steve Koch advised the new road maps Ryan Cardinal is providing will be acceptable for residents to review.

Public Comment: Residents voiced concerns about the City of Elkhorn, ETZ. The ETZ allows the City of Elkhorn to deny what is built in the specified zoned area. Resident explained there is no benefit for the Town. The end date is April 2025. Resident asked if the speed limit could be reduced to 45mph during the construction phase. Resident concerned about an erosion issue on an unmaintained road behind her house. Board explained this needs to be on the agenda to be discussed.
